NOTICE OF APPEAL

THE PLAINTIFF (appellant) APPEALS to the Court of Appeal from the judgment of the Honourable Mr. Justice J. Bryan Shaughnessy dated May 4th, 2009 at Whitby, Ontario.

THE APPELLANT ASKS that the judgment of the Honourable Mr. Justice J. Bryan Shaughnessy dated May 4th, 2009 be set aside and a judgment be granted as follows:

1. That jurisdiction and venue be in Ontario and that the statement of claim has been properly served according to Rule 17.
2. Costs of the Appeal be paid to the appellant.
3. Such further and other relief as counsel may advise and this Honourable Court permit.

THE GROUNDS OF APPEAL are as follows:

1. The learned judge erred in fact and law in finding the Ontario Superior Court of Justice to have no jurisdiction over the proceeding.
2. The learned judge erred in fact and law in finding that Ontario is not a convenient forum for the hearing of the action.
3. The learned judge erred in fact and law in finding that there has not been proper service of the Amended Statement of Claim in compliance with the Rules of Practice and the Hague Convention.
4. Such further and other grounds as will be advised upon receipt of the transcript, review of evidence and in the appellant's factum to be filed.

THE BASIS OF THE APPELLATE COURT'S JURISDICTION IS:

1. Section 6(1)(b) of the Courts of Justice Act - an appeal from a Final Order of a Judge of the Superior Court of Justice.
