

The People's Democratic Congress (PDC) shall continue doing whatever it thinks that is politically legally possible to help the broad masses and middle classes of this country PERMANENTLY REMOVE the DLP and BLP from the parliament of this country within the next six years, and thereafter then, too, to help these said classes of people do the logically correct thing and ABSOLUTELY ELIMINATE these said DLP and BLP infidels once and for all from the political landscape of this country.

The facts are that these factions have - within the last 25 years or so - become two monstrous, and, indeed, two national disgraces and scandals – of unseemly proportions - that have clearly overspent their time in Barbados!!

Indeed, the long and lengthening trawl of gross and reckless DLP/BLP governmental mismanagement, corruption and scandal over the years, would at this stage not have been so extensively defiling and polluting the political landscape of Barbados had the broad masses and middle classes of people of this country had the foresight in the 80s or 90s to have thrown these odious bacterium straight into the political sewerage outflow.

But, unlike the majority of Barbadian people of those times, a growing number of Barbadians and we in the PDC will continue to herald and proclaim the absolute necessity of bringing to an end the existence of these destructive monsters before they do greater and more irreparable harm to Barbados. For, these most sordid of political decrepits have been bearing brutal testimony to the worst that organized politics have become in Barbados at this stage.

So much have the DLP and BLP vandalized and ransacked most of organized politics in this island, that they have long started to endanger the psyches and sicken the stomachs of not necessarily the sadistic exponents of such villainous exploits but those of a politically unsuspecting and hapless majority of people in Barbados. Nothing more nothing less!!

Surely, the PDC is neither about mincing any words, nor about sending any mixed confused signals, nor about selling our birthrights for a daub of political status on matters of such great import. Furthermore, we strongly condemn the fact that the DLP and BLP continue to falsely believe that they have to deceive, lie to, and continue to muck up - without apparent consciences - many of the broad masses and middle classes in this country, on so many fundamental issues of concern to these said classes – especially in regard of the way how the political economy of Barbados is now performing. What makes this situation worse is that these brutes think that they can be held up as some of the intellectual and political leaders of this country of this time.

But, we will persist in calling a spade a spade. There are NO intellectual and political leaders in the BLP and DLP of any approaches causes movements from anywhere to anywhere within the wider Barbadian society. None whatsoever!!! For, leadership is not about merely killing time in and holding down some of the more infamous positions in any political or other organizations for petty personal gains. Nor is it

about committing oneself to making sure that as many people as possible of the broad masses and middle classes are so politically brainwashed and exploited by the relevant ideological, philosophical and psychological means, that they end up being incapable of making the distinction between those very ignoble schemes that help to secure the personal familial financial corporate and cronistic interests of the organizations' so-called leaderships, principals and cohorts, and those very evil schemes that help to make sure that the fundamental interests of the public, the nation and the country are totally and indecently subordinated and sold short.

But, the only major way in which the DLP/BLP have been able to scandalously secure such subsidiary interests, and at the expense of the fundamental interests of the public, have been for them to make it a custom of theirs to block and obstruct - and for as long and as much as possible - the national developmental process of this country.

Here are just three described ways – out of many others - in which they do so.

1) They have been taking turns at holding onto sovereign power and authority in this country. By this very fact they have been able to eventually secure for their leaderships, their principals, their cohorts, etc, as many material, financial and other benefits as possible that would ordinarily flow from such.

2) They have been making sure, in whatever ways – and for as long as possible, if can be – that the vast majority of people of these two classes see it as their lot to NOT ONLY exist within a state of chronic dependency, misery and penury – BUT ALSO to ceaselessly dutifully reproduce enough of such circumstances of dependency misery penury of their own that they would think eventually that such is their lot - Check the very damning case with those particular entertainers - who for whatever reasons have been asked to get licenses from the Town and Country Planning to stage Crop Over fetes – but who although they have had the potential power to help turn fetes on these insensate elected people, have been refusing to do so. Such people it seems preferred instead to be made to look like beggars in organizing some events that are truly theirs - what abject foolishness too on the part of those entertainers;

3) And where the means for doing 2 have proved to be ineffective and anti-thetical, these factions have been deliberately, openly and clandestinely – and where necessary, in association with some other groups (esp. some media groups), getting between the broad masses and middle classes and their otherwise achievement of sustained upward social mobility and progress in this island.

And where 3 above is concerned, a skeletal analysis of the recent presentations of the 2012 Financial Statement and Budgetary Proposals by the Minister of Finance, and of the BLP's Budget Reply, would have definitively shown how these two archaic and putrid factions would have again interposed themselves between the vast majority of people, and the achievement of some of their potentialities. For, they would have got many people in the country to significantly attend to them at that time – as is their wont - but not without these same people losing much time and energy in coming up with what proposals, measures, ideas, etc, that they might have better come up with to help themselves and to

help others, politically socially etc., - let us say if they had been that able to see it fit to possibly have come up with such things.

Also, in their use of their respective recent Budgetary presentations, in their use of the power of unity of opposites, and in their use of the media coverage of some of their linguistic speeches, bodily gestures, their attires, etc, they have also been using such things as TESTS for deciphering what could have been the levels of moral political support/responses they were at the time getting for their own policies and programs among the people. So puny minded are some of these people!!

Well, for us in the PDC, though, we would have used those presentations and much of the entire culture that surrounded such presentations to test for, and upon some measure of study, to come up with evidence of confirmation of the hypothesis that NOT ONLY are the DLP and BLP totally irrelevant to present day Barbados, BUT that ALSO many of the people of Barbados are wasting time and energy on them.

Hence, there was for another year, for the umpteenth time, in the Budgetary proceedings in the House of Assembly, the spewing out of DLP proposals and BLP counter proposals in the House of Assembly – almost like Manifesto pledges made from the political platform – and the usual ensuing sometimes rancorous, sometimes emotional, sometimes trite, partisan utterances by the other members on different sides of the aisle. But very instructively, very outrageously still, there is NOT, there was NOT, and there clearly has NOT been any legislative process in place for any number of constituents, political interest groups, etc, to deconstruct such proposals, or to add or take away from them. No political constitutional anything of the sort. None whatsoever!! No political constitutional anything that has ever been put in place by the DLP or BLP to allow for such constituents, political interest groups, civic and church groups to be a part of the budgetary process, or the legislative process itself, of the government of this country, whereupon at the end of the day there would have been the strengthening of the national governance process and the setting of the country on a likely path to becoming a democracy.

Too, there is and there has been no politically or constitutionally anything by these inane DLP BLP factions, for all these years that they have been around, to make themselves accountable responsible to the broad masses and middle classes of people for such important national matters and thereupon in the final analysis to augment the state building process and to thus set the country on the likely path of becoming a beacon of governmental excellence for others to follow within CARICOM. Not even a system of recall of elected House of Assembly people. Even the joke committees of the House or Parliament have also been made to become otiose and farcical by the stupid mindless sabotaging theatrics and tribalisms carried on by the DLP and BLP; and yes, but not without the latter rendering this state's government's parliamentary process a laughing stock to serious political individuals here and elsewhere.

This is clearly the time to clear the Augean Stables of DLP/BLP people. They have demonstrated no evidence of commitment to the better management of the political and other affairs of this country. In

such a context where there is and has been no effort made by the DLP/BLP to ameliorate the national political state of affairs of the country, it must mean that from the PDC's point of view, it really makes no sense for the time being seriously analyzing or commenting on any Estimates, Budgets, Budget Replies, Budget Debates, any Appropriation Bills, and other parliamentary bills and laws, unless such empowering democratizing accountability processes are put in place to help make this country a brighter and better one. Certainly and only certainly, if there were any such legislative measures that threaten certain guaranteed human rights, human existence in Barbados, the integrity of the Barbados state, etc., then would we seek to pay much attention to such measures.

For, the last budgetary presentations and debates were the first time in the recent history of parliamentary politics that any of the members of the PDC did not make it a necessity to go and be following such presentations. But, we strongly believe that our time and energy were better spent focusing on the finalizing and publicizing of something fundamental that we think means so much to academic, scientific and public discourse in this country.

This monumental something is called the MONEY TURNOVER RATE THEORY. This THEORY describes and explains the estimated rate at which local money is turned over between the various political economy, service industry, household, individual and other relevant sectors at the national level in Barbados. It duly takes into consideration the fact that local money is held in stock in multifarious amounts and in innumerable points in Barbados, and is TURNED OVER whenever it is used up. Also of fundamental consideration in regard of this THEORY is the assumption that money is of far greater importance than those things that it is exchanged with, in any acquisition or disposal or maintenance by any persons businesses and other entities in this country of any of those other things that are to be primarily used for social political cultural recreational purposes. Thus, for every local dollar that is collected and spent, the amount of local money that is turned over by these sectors is primarily defined by these relevant sectors presenting more or less opportunities (and dependent on other variables) for others – within and between those sectors – to get money to spend with many others.

Through the use of the appropriate methodological framework and the rigorous study of the apposite data and information, we have come to the conclusion that for 2011 the estimated rate at which this was happening was a miserable 70 % of the monetary base of this country.

Along with our using again the identical methodological structure for studying the operationalization of this MONEY TURNOVER RATE THEORY in Barbados, we have also studied the previously applicable data and information relative to this the time period 2007, and have found that the estimated rate of MONEY TURNED OVER for that time was a more impressive 80 % of the monetary base of the country. From this one could see the very adverse implications for further egregious declines in the performances of the political economy and service industry sectors of Barbados and for further horrible declines in the standard of living in this country, if the MONEY TURN OVER RATE continues to slide downwards.

Finally for now, and until another time when we are going to give greater insights into this THEORY on BU, we have to state that having in our second last BU submission DESTROYED THE VALIDITY OF THE THEORY OF VALUE IN THE ECONOMICS DISCIPLINE and the NOTION THAT MONEY IS A UNIT OF ACCOUNT in the world of ideological commercial affairs, we must also in this particular article – and by using this said MONEY TURN OVER RATE THEORY – completely dismiss the notion/the thesis that there are partial and or general equilibriums in sectors of the political economies and service industries of countries of this world or in any of these national economies and industries themselves, and that these things along with national income and expenditure accounts must balance or tend to balance.

While it is true that business accounts can be sometimes made to balance, the facts of the matter are that money – as a store/stock of value – and that money - as a non-tradeable commodity - being carried around in a money-denominated business commercial transactions environment anywhere – must have its own inherent digitized value. What this means is that except against its own value – money is completely incapable of balancing its own digitized value against those things that do not have such an inherent digitized value.

Hence, the rate at which money is CONSTANTLY TURNING OVER – whether it is at a high or low rate, and whether it is in whatever quantities, wheresoever – reflects and reinforces the notion that there are so many, many thousands of people competing with and against one another, and sometimes some people in harmony with one another's agendas, at various endless times, for money, that driven by their own social political and other needs consistent with their own social rankings, there must exist at all times in Barbados a state of permanent disequilibria in all major material and financial affairs of this country.

So there you have it.
