I dont comment as much these days, but I keep an eye on the blogs, and when I saw this recent post on BFP I let them know about the situation with the computer in parliament. I only use my personal computer at home and the one in the members lounge in parliament to blog. The one in the members lounge is really for members and their personal assistants, but I see visitors in the lounge sometimes. There is no security inside to get in you need to be checked in at the entrance and get a visitors badge, but once inside you can go to most of the areas. I often see the name of the person before me as a commenter when I blog. And I see people blogging on that computer often. The most frequent blogger there is Ronald Jones. Oh, you have a blog too? Keltruth yes I see that BFP is highly supportive of your blog.

Where are you located? Oh, Miami? Since 1979 you seem very young for that (I told him I am 53 he is 40). I am coming up there to take my wife and children to Orlando. We usually stay near the Miami/Broward border, in Aventura when we are in Miami, just behind the mall, at Turnberry Isle (I think this is a country club). I will take your number for the next time, but this time we will be in Orlando for (two or three, not sure which) months. We will be visiting EVERY attraction there. Yes, we plan to spend a day at the Holy Land Experience (I described it enthusiastically). The children plan to ride every ride, so they wont mind the heat (I recommended the water parks).

How are you related to the Deanes? I told him. He knows Malcolm and I did very well (I said I was not close to either, but there were 17 of us grandchildren, and we all hung out together a lot in the past feuding now). But Malcolm is younger under 50, right? (I said no, he is older than I am, but not much, hes either 53 or 54).

How did you get in to the USA? (Through Ian, exceptional ability in Physics, US Navy grant at the University of Miami - told him a little about my job and Ians). (You are a dentist, right?) I am a dental surgeon.

How I started blogging I googled my own name and found BFP, in conjunction with Owen Arthur. Decided to start a BLP blog to tell our side of the story - usually no moderation on comments except curse words not enough time. But there have been times when Mia calls and says take down a certain comment and I do.

The Kingsland Estates property on the beachfront, where the Garage used to be, is across the street from property I own, and I can tell you it is definitely sold. There is plywood all around it and there will be condos for 2 million apiece, called (something like) Ocean 2. It sold to Da Freitas, the man who owns the chicken place, for 18 million. (I had told him I had heard a rumor that it sold for 12 million and resold for 18).

(I told him I was sorry to hear that he was getting out of politics, because he is the sort of politician that I would probably vote for free speech, modern technology, straight shooter, etc. But getting out might be better for him, because maybe hes a little too straight for the job). Last elections it was government for sale votes sold to whoever could pay the most. BLP used to subsidize essentials, like oil and food, used to reduce taxes on fuel to keep the prices low. (I said that we were having price increases too, and that the US should drill more and develop our own oil). David Simmons visited the court a few weeks before. For instance, the Barbadian courts ruled that no financial statements were necessary. PWC another defendant in Canada valued the whole company at 5 million Barbados dollars. With 2/10th of a percent selling for 18 million, that is ridiculous. By the way I used to work for Coopers). (I mentioned the threats delivered by Peter Simmons, and Johnnys lost job). That must be a personal thing. Peter Simmons is no friend of the government he sued the Barbados Government for wrongful dismissal when he was recalled as high commissioner.
